

ADRENALINE MARATHON & HALF MARATHON

The Eisenbahn Trail is a 25-mile trail extending from the historic city of West Bend into the glacial countryside of eastern Wisconsin. The full marathon will begin in Eden and will leave the trail periodically onto rural roads. When the participants are off the trail, the course is open and runners should follow open course rules. This course is a USATF, Boston Qualifier Marathon.

Plenty of water/aid stations and Porta Potties will be available along the course. The Finish Line will be located behind the Kettle Moraine YMCA River Shores location. Participants must be 14 years or older.

REGISTRATION AGREEMENT AND LIABILITY WAIVER

1. Authority to Register and/or to Act as Agent: You represent and warrant to The Council on Alcohol and Other Drug Abuse of Washington Co. ("The Council") and the Kettle Moraine YMCA ("The Y") that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"), including full authority to make use of the credit or debit card to which registration fees may be charged. As used in this Agreement and Waiver, "The Council" refers to The Council on Alcohol and Other Drug Abuse of Washington County and any and all affiliated entities singly or together and its officers, employees, volunteers, sponsors, contractors, subcontractors and agents. "The Y" refers to the Kettle Moraine YMCA and any and all affiliated entities singly or together and its officers, employees, volunteers, sponsors, contractors, subcontractors and agents.
2. If you are registering a child between the ages of 13 and 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties.
3. Waiver: You understand that participation in the event is potentially hazardous, and that a registered party should not participate unless they are medically able and properly trained. You understand that events will be held over public roads and facilities open to the public during the event and upon which hazards are to be expected. Participation carries with it certain inherent risks that cannot be eliminated completely ranging from minor injuries to catastrophic injuries including death. You understand and agree that in consideration of being permitted to participate in the event, you and any registered party, the heirs, personal representatives or assigns of you or the registered party do hereby release, waive, discharge and covenant not to sue The Council and/or The Y for any and all liability from any and all claims arising from participation in the event by you or any registered party.
4. Indemnification: You agree to indemnify and hold the Council and/or the Y harmless from and against any and all damages, costs, claims or demands, including reasonable attorneys' fees, made by any third party due to or arising from or relating to the violation of any term of this Agreement and Waiver.
5. By indicating your acceptance of this agreement and waiver, you are affirming that you have read and understand this agreement and waiver and fully understand its terms. You understand that you are giving up substantial rights, including the right to sue. You acknowledge that you are signing the agreement and waiver freely and voluntarily, and intend by your acceptance to be a complete and unconditional release of all liability to the greatest extent allowed by law.

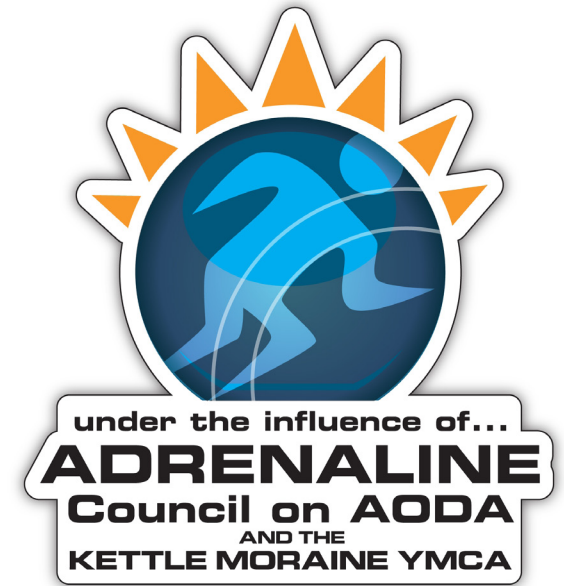
